Please read this Privacy Policy ("Policy") carefully before using the Voice-ping.com website and app (the "Service") operated by p2p Corporation ("p2p", "us", "we", or "our").

This page is used to inform website visitors regarding our policies with the collection, use, and disclosure of Personal Information for anyone using to use our Service.

If you choose to use our Service, then you agree to the collection and use of information in relation with this policy. The Personal Information that we collect is used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

The terms used in this Privacy Policy have the same meanings as in our Terms and Conditions, unless otherwise defined in this Privacy Policy

Information Collection and Use

For a better experience while using our Service, we may require you to provide us with certain personally identifiable information, including but not limited to your name and email address. The information that we collect will be used to contact you with updates to our service. You can change your email address or unsubscribe to these emails at any time.

In addition, whenever you visit our Service, we collect information that your browser sends to us that is called Log Data. This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser version, pages of our Service that you visit, the time and date of your visit, the time spent on those pages, and other statistics. When you access the Service using a mobile device, we may collect additional device information, such as the type of device you are using, its operating system, and mobile network information.

Cookies

Cookies are files with small amount of data that is commonly used an anonymous unique identifier. These are sent to your browser from the website that you visit and are stored on your computer's hard drive.

Our website may use these "cookies" to keep you signed in to our Service. You have the option to either accept or refuse these cookies by changing your browser settings. If you choose to refuse our cookies, you will not stay signed in once you close your browser tab or window.

Where we store your data

p2p transfers, processes and stores data about you on servers operated by our hosting provider located in the United States of America. Your Personal Information may therefore be transferred to, processed and stored in a country different from your country of residence, and be subject to privacy laws that are different from those in your country of residence. Information collected within the European Economic Area ("EEA") and Switzerland may, for example, be transferred to and processed by third parties referred to below that are located in a country outside of the EEA and Switzerland, where you may have fewer rights in relation to your Personal Information.
